The Independent State of Papua New Guinea has applied for [IDA Credit](#) financing from the World Bank toward the cost of the Road Maintenance and Rehabilitation Project II ([RMRP II](#)), and intends to apply part of the proceeds for consultant services. The objective of the consultant services are:

- to assist Department of Works management and provincial staff to ensure that all managerial, technical and administrative tasks are undertaken as required to implement GoPNG and World Bank funded RMRP II to meet programmed targets;
- to ensure that procurement procedures for World Bank funded projects are in accordance with World Bank's [Guidelines: Procurement under IBRD Loans and IDA Credits \(May 2004 and revised in October, 2006 and May 2010\)](#) and where possible consistent with GoPNG guidelines for procurement of works and goods and for the employment of consultants;
- to provide GoPNG and World Bank with timely and comprehensive financial and technical reports on the status of project implementation.

The services are required for the period of 5 years.

The Central Supply and Tenders Board now invite eligible consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may associate to enhance their qualifications.

A consultant will be selected in accordance with the procedures set out in the World Bank's [Guidelines: Selection and Employment of Consultants by World Bank Borrowers \(May 2004 and revised in October 2006 and May 2010\)](#).
